




Candidates receive an automated notification to securely receive their results, view their Knowledge Deficiency Report to highlight subject areas that require further learning.

## Access controlled by Invigilator

The encrypted assessment can only be securely accessed using unique login credentials by the Invigilator within the allocated timeframe.

## "Late save" if internet disconnects

If the internet has a faulty connection during the assessment delivery the result is not lost, and the assessment can be uploaded once internet connection is restored.

### **Automatic submission**

Assessment is automatically submitted when the time has expired, or the candidate can submit the assessment early at their discretion.
